NVE Maintenance Updates



A message from Walter:



Since being back at the Village, I have been working on the TMSB skirting and getting the parking lot leveled. As well as working with Enstar to have the meter and gas hooked up to the Building to get the building self sufficient with its own power. Ordered the material to sheetrock and paint the new food bank. Also worked on the roof for the L&E Dept. I will be working on getting a material list for another step for the TMSB and wheel chair ramp with overhead roof as to minimize snow and water on the ramp to help eliminate falls or slips.

Noodles and Cottage Cheese

This is an inexpensive dish to make, it can be a side-dish or add in canned salmon or moose to make a casserole. Very good paired with white fish. Serves 6 - 8 people as a side.



Ingredients:

- 1 package of egg noodles (or any noodle), cooked and drained but still warm
- 1 container of cottage cheese (either the 8 oz or 16 oz, depending on how much you like cottage cheese)
- Two medium to large potatoes cut into small pieces and cooked until soft.
- 1 stick of unsalted butter
- parsley, 1/2 cup fresh or 2 TBSP dried

In a pot (you can use the same one from cooking the noodles) melt the butter and mix the noodles back into the melted butter. Sautee for a minute or so to evaporate any water left in the noodles. Add the cooked potatoes, cottage cheese, and parsely. Heat until the cottage cheese is warm, but not melted. Can add pepper to taste.

To cook potatoes in the microwave - dice potatoes and put in a microwave safe bowl. cover with water and heat for about 7 minutes. Use a bigger bowl than you would think as the potatoes will boil over. Potatoes are done when they can be pierced by a fork easily. Can use canned whole potatoes as a substitute.

Can add:

- Chickweed, spinach, or lambsquarter
- sauteed onions
- sauteed cabbage
- Sauteed garlic
- Canned meat of choice, clams, or mussels

Land and Environment News

Daylight savings means that things are ramping up in the Land and Environment Department. We have been busy getting things ready for this summer field season, researching and applying for grants, and helping around the main office. We have also been busy with the coordination of a Community Spring Picnic, the Village Community Clean-up, and the summer Culture Camp. Currently we are looking for volunteers that would like to help with the culture camp and anyone who would like to teach a cultural skill to the youth/attendees. There will be a part time position opening to help with the coordination as well.

Believe it or not, the winter time was the slow time of year for the Land and Environment Department. We kept busy by writing reports, analyzing data collected during this summer field season, working on up-coming grants, and planning the next field season. In that mix, we have assisted the NVE Maintenance Department in replacing the roof on the Land and Environment Office, assisted the NVE Food Bank with Turkey Basket Distribution, and attended trainings to allow our staff to assist in other departments if needed. The winter season was also the continuing education season, with most seminars/webinars and trainings happening during this time. These are important for our staff to attend as they not only pertain to advancements in the Natural Resource field, but also help us navigate through federal legislation changes and granting requirement changes. Below are some recaps on some of our current projects:



Eklutna River 2021 Field Season Recap

2021 was an eventful year on the Eklutna River. As part of an ongoing study being conducted by the power companies that operate the Eklutna Hydroelectric project, water was released from the lake and into the river for the first time in decades.

During the 2021 field season, the Land and Environment Department began habitat surveys in the upper Eklutna River, conducted juvenile salmon trapping, and performed salmon spawning surveys in the lower river. These activities were performed with the assistance of a Tribal Wildlife Grant, awarded to NVE by the U.S. Fish and Wildlife Service. Here is a summary of our activities:

Upper Eklutna Habitat Surveys- In June, L&E staff performed habitat surveys in the East Fork of the Upper Eklutna River (above Eklutna Lake). Habitat units were characterized for suitability as salmon habitat. The goal of this portion of the project is to determine if there is suitable salmon habitat in the upper river, how much is available, and where it is located. Ideally, these data will be used to inform management and mitigation decision making regarding the dam at Eklutna Lake.

Juvenile Salmon Trapping- Under a permit from Alaska Department of Fish and Game, L&E staff conducted minnow trapping for juvenile salmon throughout the summer from the river mouth up until the river ran dry.

Additional trapping was conducted in the East Fork of the Upper Eklutna River. 92 trap deployments were conducted, and we documented King, Coho, and Pink salmon juveniles. We did not capture any Sockeye or Chum juveniles. Coho juveniles were found in strong numbers in suitable rearing areas.

In addition to these salmon, Dolly Varden, Three-spine stickleback, Alaska blackfish, and sculpin were also documented in the river. The Eklutna River is beyond the native range of the Alaska blackfish, and to our knowledge this is the first time this species has been documented in the system. A report was filed with ADFG.

Spawning Surveys- L&E staff began surveying the river for spawning salmon in early June and continued through the month of October. King,

Pink, Chum, and Coho salmon were observed spawning in the river. However, only pink salmon were seen in appreciable numbers. King, Chum, and Coho return numbers were startlingly low when compared to the last time NVE surveyed and are cause for concern.





More in depth reports will be featured in upcoming newsletter articles as data is analyzed. All three of these projects will continue next year. 2022 work in the upper Eklutna will focus on further habitat surveys, this time in the Upper West Fork. Juvenile trapping and spawner surveys will be repeated to monitor population trends and changes in habitat usage due to the changes the river experience during the water releases this year.

Land and Environment Department Launches New Reporting Tool

Did you know that the NVE Land and Environment Department has a contaminated sites program? Through the support of the Tribal Council and the United States Environmental Protection Agency, the L&E Department keeps track of contaminated sites in our area and works with the Alaska Department of Environmental Conservation (ADEC) to ensure that contaminated sites are assessed and cleaned up in a timely manner.

One type of contaminated site that we deal with are known as Brownfields. Brownfields are contaminated sites which could be targeted for cleanup and reuse or redevelopment. According to the



EPA, a 'brownfields site' is defined as real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant. Another Brownfields site qualification is that there is no solvent responsible party. We obtain information

on new sites from the ADEC and from community input and are now launching a new tool to make it easier for you to report a potential Brownfield site to us.



You can now use an online form to report a contaminated site. You can find the form using the QR code on this page or by visiting the Contaminated Sites page on the NVE website. There you can enter information regarding the location and the issues that you are concerned about regarding the site. You can also leave your contact information so that a member of the L&E Department can contact you if we need any further information (contact information is optional and will not be shared).

This form is to be used to report a potential Brownfield, **NOT to report a chemical or petroleum spill!** If you need to report a spill, contact ADEC at 907-269-3063 during business hours or 1-800-478-9300 outside of regular business hours.



Adopt-a-Highway



The Land and Environment Department would like to adopt a stretch of highway on behalf of the Village of Eklutna through the Alaska Department of Transportation. Adopting a Highway is a great opportunity to beautify our community, protect our environment, and show pride in our home! Adopting a highway is a 3-year commitment to clean the adopted stretch of highway three times per year. Eklutna Vocational School Cemetery



Several likely graves associated with the former Eklutna Vocational School were located in forest across the highways from Eklutna Village and described during cultural resources survey for the Old Glenn Highway bridge replacement in 2014. NVE subcontracted assistance to the project, and George Ondola and Tim Alex located the graves. There is one wooden grave marker for a young woman, possibly from Tyonek, born in 1911 and died in 1928. Esteemed former Elder George Ondola also indicated 2 unmarked graves close by and said there were around 8 graves in the area from the 1930s, which was during the school operation. Some indistinct, shallow depressions under leaf litter were noted in the area, but not further investigated.

For over 150 years, beginning around 1918, the United States enacted laws and policies promoting Indian boarding schools across the nation. US Indian boarding schools were designed to culturally assimilate Indigenous children by forcibly relocating them to distant facilities where their Native identities, languages, and beliefs were suppressed. Many students suffered injury and abuse. Some died and were buried in unmarked graves.

In 2021 the US Department of Interior, under Secretary Deb Haaland, initiated the Federal Indian Boarding School Initiative to address the intergenerational, traumatic impact of Indian boarding schools, starting with archival records research being pursued by BIA. This occurred as the remains of more than 1,000 Indigenous children were found at former residential schools in Canada.

NVE is applying for a small grant to participate in and guide addressing the Eklutna Vocational School Cemetery. Phase 1 would include investigating historical knowledge and records, and consultation with BIA, which is tasked with finding relevant archives. Ground penetrating radar (GPR) assessment would be contracted to verify and further characterize the graves. Some clearing, to be minimized, would be needed to conduct the GPR. Phase 2 would use information from phase 1 of the cemetery investigation. It could include consideration and installation of a memorial monument for the graves. Other commemoration could also be considered. More consultation with Federal and other Tribal governments whose youth may have been relocated to Eklutna and impacted, could be included to commemorate and manage the cemetery.



NALMEP Fall Survey

The FY22 NALEMP field work was conducted this past October. This was the last section to be surveyed using the magnetometers for burried drums and included the current Eklutna River Channel. No drums were found, although there was a wide array of debris in the area from the recent water release and from the highway. Smaller items were removed at the end of the survey, but larger items remain to be picked up. The next NALMEP work is being planned and would not start until FY23.

ETCD NEWS



The ETCD has been working hard on getting the supplies and logistics ready to bring in a conex and set up the hydroponics area of the greenhouse and create the outdoor community garden. We are narrowing down the choices of what to grow this first year – focusing more on the greenhouse/hydroponics area for year one and designing the outdoor area to provide the maximum yield for the area available. We will be clearing some land and using the trees as the base for a hügelkultur style garden and biochar to help ammend the soil. Some of the plants we would like to grow this season are: brocollli, cauliflower, rhubarb, cucumber, tomatoes, lettuces/kale, and herbs. We are making the decisions on what to grow based off of the community survey that went out online a few months ago. Bat Science Opportunity in Eklutna

Bats are an important part of the ecosystem and help control insect populations- including those pesky mosquitoes! According to the National Park Service, bats provide more than \$3.7 billion worth of pest control annually.... For free! Certain species are important pollinators as well. Unfortunately, bat populations are in decline due to multiple threats including climate change, habitat loss, and a fungal disease known as white-nose syndrome (WNS).

Alaska is home to at least six species of bats, but the one we are most likely to see here in Southcentral are little brown bats. They are only about 3-4 inches in length with about an 8.5-inch wingspan, but they fly at an average of 12mph, with a top speed of around 20 mph! They typically live around 10 years but have been reported to live up to 34 years. Little brown bats are fairly widespread here in Alaska, but little is known about their population numbers or winter hibernating locations.

Alaska Department of Fish and Game have joined with the North American Bat Monitoring Program to monitor and find out more about bat populations in our area. The Land and Environment Department is joining this partnership and will be deploying acoustic monitoring sensors in our area next July.




