Presidents Message

Yagheli Da,

This Spring and Summer has been a busy one for me and the tribe, I am humbled to continue to serve as the president. Unfortunately, as you are all aware, shortly before the election a confidential letter was sent out to the tribal members and we have hired a private investigator to see what we can learn about who may have sent it and how we can tighten up security procedures so that this doesn't happen in the future. As I am sure you are all aware, largely due to the Delta Variant of Covid we have seen an uptick in cases with our tribal members and we are working hard with our partners at SCF and CITC to make sure that we can adequately provide the resources we have at our disposal to assist our membership.

In late May the Tribe met with the Anchorage Assembly for our first Government to Government meeting and we are looking forward to hosting them in the fall at the tribe as we continue to develop ways that our two governments can work collaboratively. We also recently successfully had our annual NVE EI meeting and we have several items to follow up on as our two organizations continue to work together.

I had the opportunity to represent the tribe by giving a welcome to the NCAI midyear meeting, providing a history of the Dena'ina for Cook Inlet Tribal Council, met the First Lady of the United States and the swearing of the first African American Police Chief in Anchorage. I am also happy that in early August we were able to dedicate first Dena'ina place marker throughout the city, this is an ongoing project that will likely take year to fully realize but it was good to have such a large turnout and media coverage of the event.

Another landmark event in our tribes history is the releasing of water down the entire Eklutna River, this has not happend since 1929 and is massive achievement for tribe and the hard-work over several decades by past leadership and staff. This is truly something that our entire tribe can celebrate and we will continue to push for more water to flow down the river and hopefully restore some of the salmon run to the Eklutna River.

As you all may have read in the paper recently we recieved a negative ruling by the US District court in our lawsuit with Department of the Interior. This is certainly a setback and we currently reviewing our options to determine what if any course of action will be taking.

I also would like to take moment to thank Richard Farber for his dedication to the tribe and wish him the best on his new endeavours. The Tribal Council has decided to appoint Dorothy Cook as the Acting Tribal Adminstrator as she has served in this role in the past and we will be begining our search for a replacement in the near future.

And lastly, I want to let tribal members know that we still have COVID funding available for those that qualify under the guidelines set forth by the various pockets of money. If you have already applied and have not recieved feedback or you have questions please reach out to the staff or get in touch with council so that we can hopefully resolve and issues and make sure that the funding goes to those who qualify for it.

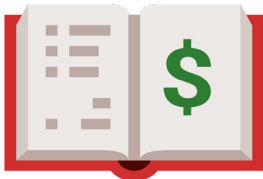
Once again its my honor to serve all of our people and want to wish everyone health and wellness as we move into the winter season.

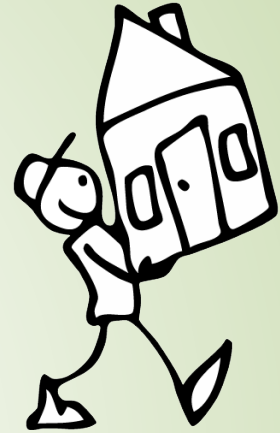

On Saturday September 18, Trout Unlimited Alaska hosted an event at the Canyon Campground in Eklutna State Park. This event was to celebrate the temporary release of water from the upper dam on Eklutna Lake down the river. The release is part of ongoing studies on the Eklutna River and is designed to allow researchers a look at sediment transfer and water channels in the river basin. This is the first time this amount of water flowed in the Eklutna River for almost 70 years. NVE Land and Environment Department had a booth at the event with information about the river. The event was attended by close to 150 people.

Aaron Leggett gave a few words at the event, along with Curtis McQueen (Former CEP for Eklutna Inc.) and Eric Booton (Trout Unlimited).

The flow will be halted by October 6th, and the next step will continue on the Eklutna River project.





NVE COVID ASSISTANCE APPLICATIONS

The Native Village of Eklutna continues to provide Covid assistance to Full Tribal and Adpotive Tribal members and families. Applications for 2021 are being accepted. While the limit is for \$500, the Council authorized additional assistance for those with very low income and limited resources. This is the same application form that was mailed out to Tribal Members in 2020 and can be used for household bills, Internet and Electronic devices for communication, phones, sanitation supplies, etc. Help for filling out the form is available upon request. It is imperative that we have all supporting documents in order to process your application. Please ensure that we have your updated contact information when applying for assistance.

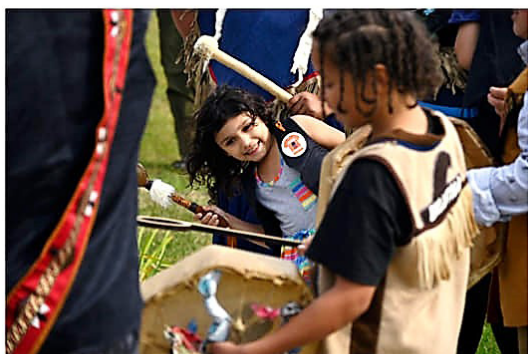

After years of NVE requests and Aaron Leggett working for the Anchorage Museum, Dena'ina signage has gotten backing from numerous organizations, including the Anchorage Parks.

With short notice, Ida'ina K'eljeshna (Friendship Dancers) and many other peoples gathered to celebrate the first step in many installations to be placed throughout Anchorage.

Aaron reported to Indian Country Today, "In 2006, the Dena'ina Center opened, and it was kind of a shocker for most people because they'd never heard the name Dena'ina. They Didn't think about Anchorage being an Indigenous place.

"Leggett said the growing awareness prompted the Eklutna tribe to do more to build Anchorage's identity as an Indigenous place." (Anchorage Daily News, August 12, 2021)

HEALTHY EATING

It has been requested that we share some recipes to use either traditionally harvested food or vegetables harvested from local gardens in our newsletters. The staff have shared some recipes, but we would like the community to submit their favorites. Our first recipe was submitted by a staff member as a delicious way to use harvested blueberries.

Gega Layered Dessert (blueberry)



Crust:

- 1 C. flour
- 1 stick of butter
- 1 C. chopped walnuts

Mix flour and room temp butter. Add walnuts. Press on bottom of 9x13' pan. Bake at 350 for 10 mins, cool

Blueberry Layer:

- 1 C. Sugar 3 Tbsp. dry blackberry jello
- 3 Tbsp. cornstarch 1 Qt. blueberries, fresh or frozen
- 1 C hot water

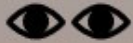
Heat sugar, cornstarch and hot water. Stir constantly until clear and thick. Add jello; stir until dissolved. Add blueberries; cool and then drop spoonfuls on crust and spread evenly over crust. Chill well.

Cream cheese layer:

- 1 (8oz) pkg of cream cheese 1(8oz) cool whip cream
- 1 C. powdered sugar

Whip the cream cheese and sugar with mixer until light and fluffy. Fold in whipped cream. Place topping on the cooled blueberries and spread evenly; chill well

Carbon Monoxide

Odorless

- Carbon monoxide (CO) is a colorless, odorless, tasteless gas that can lead to poisoning
- It is generated when fuels are burned (heating oil, gas, wood, etc.)
- Common household sources are fuel burning appliances, fireplaces, grills/BBQs, and vehicles
- Carbon monoxide poisoning is responsible for about 50 deaths and 15,000 emergency room visits nationally every year, according to the CDC

Symptoms

- Nausea
- Dizziness
- Tiredness
- Shortness of Breath
- Headache
- Confusion



***If you experience these symptoms and think it could be from CO poisoning, or if your CO detector sounds, **get to fresh air immediately and call 911!** Open windows to ventilate the area, turn off combustion appliances, and leave the house.

Prevention

Do

- **Do** use a carbon monoxide detector with backup battery power
- **Do** have fuel burning appliances vented properly and inspected annually
- **Do** follow manufacturer instructions on proper use of fuel-burning appliances

Don't

- **Don't** idle cars in garage
- **Don't** use grills/BBQs inside
- **Don't** sleep in a room with unvented gas/kerosene heaters
- **Don't** use gas powered engines indoors
- **Don't** ignore the symptoms

“Life with Eklutna River” - Interviews & Artwork

PURPOSE: To Document the historical use of salmon by the Eklutna tribe to quantify the true cultural cost of the loss of salmon in the Eklutna River and communicate the need for strong mitigation efforts to recover these losses through the development of a written TEK Assessment lead by Native Village of Eklutna.

INTERVIEWS: An interview form was finalized to collect your Traditional Ecological Knowledge (TEK) – your memories and stories about life around Eklutna River (including the lake and lands nearby). The first interviews will be from the Tribal Council and Eklutna River Committee. We will then ask for Tribal Member participation. Interviews can be done by filling out the form or by having someone interview you (in person, by phone, or thru a Zoom meeting). Those who are not normally paid by NVE may opt for gift cards as compensation. ETCD News

In early September, demolition of an old greenhouse structure near the new Tribal Member Services Building was undertaken by the Eklutna Tribal Conservation District (ETCD) in partnership with Alaska Villages Initiatives (AVI). The greenhouse is being deconstructed, and any suitable materials are being salvaged for reuse. The site is being cleared and prepped for the installation of a new greenhouse, demonstration garden, and hydroponic growing facility. The new facility will help Eklutna address food security issues and provide a location to provide education events for our community focused on food production.

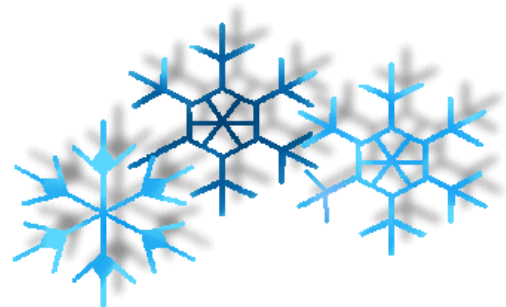


The greenhouse site as of 9/8/2021.

Land and Environment News

The Land and Environment has been very busy this spring and summer. Field season for all the grants was underway and we have been busy working in the field, attending seminars and meetings, and the day to day operations of managing the LE Dept. Some of the broader accomplishments are:

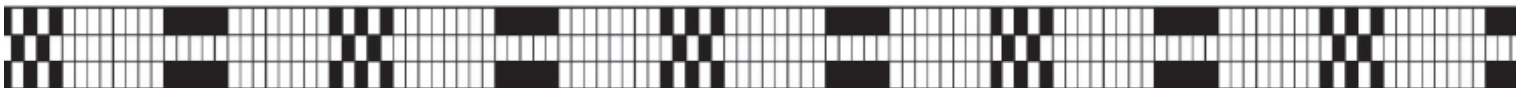
- NVE completed the first part of the current NALEMP survey this May. The section surveyed area surrounding the village. This fall we plan to survey a second area that crosses the Eklutna River. We are looking for buried drums that may have contaminated substances in them. We found no drums this spring.
- The Tribal Wildlife Grant work started in June. We are working on a habitat characterization study on the tributaries that lead into Eklutna Lake. Fish counts and minnow trapping in the lower river are also part of this study.
- Emergency management hazard mitigation planning has started. This plan is for the village and surrounding area in preparedness for natural or man-made disasters. The village area does fall under the Municipality of Anchorage's plan, but it is suggested that each village/town complete its own plan on the smaller scale. A draft will be posted for public review before being completed (as per FEMA). Look for this at the end of summer. If you have any considerations for a plan, please contact the LE office. We are open to all suggestions.
- The Tribal Response Program is going strong. We are asking for suggestions of sites that are of interest to the Tribal Community to add to our list of NVE Prioritized Contaminated Sites List. If you have an interest in a site of concern, please let us know so that we may add it to our list. Submissions can be sent in via our website or by emailing krobillard@eklutna.org. Sites on the list are given priority for the LE Department to research and discuss with ADEC.
- The LE Department has been part of a board that is working on restoration efforts for the Eklutna River. This board is comprised of members from the USFWS, NOAA, Trout Unlimited, Conservation Fund, ADF&G, DNR, Chugiak Electric, AWWU, and McMillian Associates. The board is working on research studies and solutions to restore the flow to the Eklutna River.

- The LE Department has also been part of discussions with the US Department of Energy and an Alaska group called ALICE on a Pumped Hydro Storage alternative to replace the current electrical turbines for the power generation from Eklutna Lake. This alternative has the possibility of letting the Eklutna watershed behave naturally, which will help with the restoration of the river. The project is still in the feasibility phase. More information will be provided as it becomes available.
- NVE has a seat on the Anchorage Historic Preservation Commission (AHPC). AHPC developed a Local Landmark Ordinance (LLO) that was approved by the Anchorage Assembly. The LLO allows entities to nominate historical sites for a registry so they can be recognized for their historical significance. NVE Council decided the old railroad section house that was moved to the village from out toward Girdwood, the Eklutna knobs, and the Peters Creek ancient Dena'ina village should be nominated for their historical significance.
- A press release was released this summer with the title “Alaska Federation of Natives Endorses Restoration of Eklutna River”. This press release has been distributed nationally and the whole press release is at the end of this newsletter.

NVE 2021 CULTURE CAMP

The 2021 Culture Camp was held August 2 through the 6th. The camp was held at the NVE pow wow grounds and had 51 participants throughout the week. The camp was not reserved just for youth, all ages were encouraged to attend. We had a good mix of adults, elders and youth. The youth ages ranged from under a year to 18. This camp was designed to be a day camp with one night with the fish net. Port-a-potties were rented, a water buffalo was onsite with non-potable water, and hand sanitizers were scattered around the main table area.

Some hiccups were experienced through the coordination of the camp earlier this summer, but these were overcome and the camp went off without any issues. Some of the activities completed at the camp was a plant walk, nature walk with young kids with animal track id, berry identification, language and storytelling, fish spear making, fish net setting and fish processing, and the main event – cache making. The youth and adults that participated had a good time. Some suggestions were made for next summer's camp as items to add, such as beading, archery, and native games. The fish net was set on Tuesday of the culture

The culture camp set out the net during the week. A different crew set the net than the crew that pulled it back in, but all learned and had fun. Elder Lewis Stephan helped teach the setting of the net while the Doone Family, Garcia Family and Wasky family were there to help pull in the net. In total, 8 fish were caught.





The fish net was set on Tuesday of the culture camp week. The intention was to spend the evening with the net and anyone who wanted to camp was more than welcome to. The tide went out early and we were able to process the 8 fish caught earlier than expected. The participants learned how to cut the fish, set and pull the net, and check the net for any damages. An eagle pair decided to come watch us process the fish and took off with some scrap. The fish were grilled the next day for lunch.

Dena'ina language scholar was able to talk with us on Tuesday afternoon about language, stories, and songs. He shared resources that have some stories written from Dena'ina around the Cook Inlet.



NVE elder Laura Chilligan was able to help teach how to make a cache. The participants of the camp made a cache replica that will be housed at the one of the tribal buildings in the village. It took two days to complete the cache, and there were many participants involved in the whole process, from gathering the small trees, peeling the bark, and constructing the cache.



The camp was made possible by a BIA grant and a small grant through the Association on American Indian Affairs.

NVE will be looking to again hire a seasonal coordinator for next summer's camp and to have some volunteers to make the next camp even better.



ALASKA FEDERATION OF NATIVES ENDORSES RESTORATION OF EKLUTNA RIVER

Calls for Release of Water to Support Salmon and Eklutna Dena'ina

ANCHORAGE, Alaska (March 17, 2021) — The Alaska Federation of Natives (AFN) recently endorsed the restoration of the Eklutna River near Anchorage, Alaska. AFN, the largest Native organization in Alaska, passed a resolution at their annual gathering calling for a free-flowing Eklutna River to support the recovery of Pacific salmon and benefit Dena'ina Athabaskans from the Native Village of Eklutna (NVE).

"Alaska's rivers and streams have provided nutritional and cultural benefit to Alaska Native people throughout time immemorial, and the Eklutna River is no exception," said Ben Mallott, AFN vice president. "Through Resolution 20-17 AFN expresses our support of efforts to restore traditional rivers and streams for fish and wildlife habitat, traditional subsistence uses, and sustainable natural resource development, and in particular, the efforts of tribes like the Native Village of Eklutna." The Alaska Federation of Natives represents 168 federally recognized tribes, 166 village corporations, 8 regional corporations, and 12 regional nonprofit and tribal consortiums. The annual gathering is the largest within Indian country in the United States.

"We are grateful to the Alaska Federation of Natives for their support," said Aaron Leggett, Chief of the Native Village of Eklutna, "and to the many Alaskans and Americans from across the country who have followed this story." The Native Village of Eklutna is the only traditional village within the Municipality of Anchorage. "We have supported the growth of Anchorage and Southcentral Alaska," said Leggett, "but now it's our turn. Salmon are part of our culture, they make us who we are. But without a free-flowing Eklutna River, the salmon struggle and we struggle."

"The Eklutna River and the salmon it provides are vital to the Native Village of Eklutna. For generations, members of the Native Village have been committed stewards of this precious resource," said Congressman Don Young. "I have been involved in this process for quite some time, and was one of the strongest proponents of removing the Lower Eklutna River dam to allow salmon to move upstream once again."

The Eklutna River was the focus of a five-year, \$7.5 million dam removal project completed in 2018 by the Native Village of Eklutna, Eklutna Inc. and The Conservation Fund. The Lower Eklutna River dam was built in 1929 to provide Anchorage with its first major power source. The lower dam was abandoned in the 1950's when a larger power project at Eklutna Lake diverted all the water out of the Eklutna River.

The effort to remove the lower dam involved a vast array of funders, including the Rasmuson Foundation, Resources Legacy Fund, the National Fish and Wildlife Foundation, the Mat-Su Salmon Partnership, Orvis, Patagonia, and the Alaska Community Foundation. Curtis McQueen, former CEO of Eklutna Inc. and current board member of the Rasmuson Foundation, said "This is such an exciting story that everyone wants to be in on. Just as we have seen with dam removals elsewhere, like the Elwha River, when you let the river run free the fish come roaring back."

Diane Kaplan, President and CEO of the Rasmuson Foundation, a financial supporter of the dam removal project, said "When you talk to elders and learn the historic connection between Eklutna River and the Dena'ina people, you begin to understand how important this project is. The Dena'ina people of Eklutna have never stopped fighting to have their river restored, and this dogged determination, reminiscent of the salmon they fight for, has brought them one step closer. It was an honor to support their efforts."

Despite the success of the dam removal project, the Eklutna River is still largely devoid of water because of diversions for hydropower generation. "It's one step at a time," said Brad Meiklejohn of The Conservation Fund. "Now it's all about getting water back to the fish and the fish to the Eklutna people. It's been a long road but we are going in the right direction."

Under an agreement signed in 1991, local electric utilities are now engaged with NVE and state and federal regulators in a mitigation process to remedy the impacts of hydropower operations on the Eklutna River. That process, begun in 2020, is slated for completion by 2027; ultimately, the Governor of Alaska will have final approval of the recovery plan. "All the talk now in the meetings is about how much, when and how to get water back into the Eklutna River to benefit salmon," said Marc Lamoreaux, Environmental Coordinator for NVE. "The salmon are still there, all five species, including the mighty King salmon, and we hope they hang on just a little longer as we work through this process."

"The tribe is grateful to the utilities that our concerns have been recognized and that progress is being made," said Richard Farber, Tribal Administrator for the Native Village of Eklutna. "We have a screaming need to restore the identity of our people and that begins with restoring the salmon."

"Removing the dam was only part of the solution; we now need to secure greater water resources to bring salmon back and finish the job," said Congressman Young. "I am pleased to see that the Native Village of Eklutna has entered a new restoration phase, and I wish them continued success as they work to improve the river's ability to support wild salmon. I will continue working at the federal level should resources or legislation be needed, and I look forward to the day when the river is fully restored and becomes home to a healthy salmon population."
